However, the bit about the clerk is new and again I would simply request you provide written proof as he claims to have such many times. The P.C answer was serval of the WPC did not want to go ahead plus the figures did not stack up (I have to be truthful my impression of her line manager made this comment) my notes show 9th March 2014 that the D.C check with her superintendent/line manger and got clearance to put it full WPC. The perpetrator offered all monies to be paid back in return for a caution. See below full details in the timeline below I have set out

The email exchange of 9th March 2021 shown above, between D.C. Foreman and the two lay investigators and Roger Giles (Welney Parish Council Chair and fraud investigation supervisor) indicates that the fraud perpetrator, Mrs Copeman, wanted to plea bargain (pay all monies back in one lump sum if the WPC would agree to just a caution being served). D.C. Foreman also checked that the perpetrator had the £21k. Apparently, Mrs Copeman's mother had left monies in her will, so the money became available as this case was becoming finalised.

Following correct procedure, D.C. Foreman emailed the WPC's Chair /representative, Roger Giles, in readiness to instigate full Welney Parish Council involvement for gaining approval of the plea bargain finalisation of the case. Note the email sent by D.C. Foreman at 11.17am in which she indicates that she is awaiting circulation approval from her Detective Inspector./ Case supervisor

Once D.C. Larissa Foreman informed me that she had clearance from her superiors, I then texted Jennifer Millard, WPC's Clerk to action these matters, giving her D.C. Foreman's contact information. I was hospitalised at the time, so could not attend the meeting that Jennifer arranged.



In relation to the Copeman case, I wanted to ascertain the views of the PCC in relation to seeking a positive outcome. As you are all aware this case has been ongoing since 2018 and there have been a number of difficulties in getting the evidence together. In order to prove the total loss. Peter Cox has worked hard to produce spreadsheets and corresponding documents which details how much was stolen and the amount of money outstanding. This amount is additional to what Mrs. Copeman has already paid back.

Thank you for your recent email communication.
In an effort to respond quickly, I have emailed the Councillors seeking their opinions.
This decision will be resolved (confirmed) at an Extraordinary Meeting of the Council on Monday evening.
In summary we would be comfortable accepting that Pat is given a caution but only one the basis that the outstanding monies (which we understand total circa £21,000) are paid in full, in one single sum, at the earliest opportunity.
We note that in selecting this approach we hope to avoid further financial and administration burden on the taxpayer.
