JUST FOR REFERENCE MY FIRST CASE WAS TERMINATED BY CPS DUE TO COVID IT WAS RUN BY DC 1303 CARL RITCHIE CHILD PROTECTION TEAM

On the 2nd February 2022, D.I. Weller terminated my 2ND case, stating lack of evidence, after his evidence review (I believe that evidence must have been lost or redacted – the stated 'lack of evidence' is not true).

Just a short background:

My bone of contention with Lloyds Bank was that they did not act on concerns that I expressed in a meeting held on 27th November 2013, with my trusted Bank Manager of ten years' business, Steve Clarke. My company, Giles Landscapes, appeared to be trading well but was losing monies, dragging it into a CVA situation. My suspicion was strongly on my Financial Director, Michael Hanna, but this very experienced career Criminal had wrong-footed my accountants – Streets, Whitmarsh & Sterling. When I showed Alan Blake, my Accounts Manager at Streets, etc., some evidence I had found, he suggested that I approach Lloyds Bank for clarification.

The evidence seemed to point to a second account under the umbrella of my Business. This second account was being used to launder money from my Financial

- Also, see monies laundering, pages 47 and 63 monies from my existing account on cheque numbers not yet issued to my company.
- I am also Questioning D.I Weller's statements –

"I am aware you provided boxes of material to the PCC Office in relation to the Lloyds PLC dispute which did contain a small amount of material relevant to the Hanna Fraud".

See page 43 – evidence not followed up – plus pages 38, 40, 46 and 51 "From the material you have provided we see nothing further that would change this stance from the Constabulary. We will not be investigating this matter".

A/C 27 Dec 2013, The main perpetrator son then opened this 3rd Lloyds monies
